

Pet Agreement

(This Agreement applies to pets other than Service Animals) In consideration for the Inn permitting me to keep my pet in the accommodation I have reserved, I hereby agree to the following:

1. My pet(s) is a domesticated dog(s) and no more than two pets are permitted in my accommodation.
2. I agree to pay the non-refundable service fee for my pet(s) of \$30.00 per night, per pet. I understand that additional fees may apply in the event my pet causes any damage.
3. I must keep my pet restrained on a leash when my pet is outside my accommodation.
4. I must properly remove and dispose of any litter or waste associated with my pet on Inn premises.
5. I understand that pets are not permitted inside the Inn or on the porch dining area.
6. I understand that when inside my accommodation the pet is not allowed on sofas, chairs or beds. When my pet is in the accommodation and is unsupervised, it must be in a pet crate.
7. I understand that when it is time to service my room I must be present or the dog must not be in the room.
8. I agree to pay the Inn any charges for any necessary cleaning or repair due to pet stains and/or damage, as determined within the sole discretion of the Inn. I hereby authorize my credit card on record to be charged for the cost of these additional services and/or amenities.
9. I agree that I am responsible for the noise my pet creates and will ensure that my pet does not disrupt the quiet enjoyment of other Inn guests. I will need to provide a working cell phone number in case we must be in contact with the pet owner.
10. I agree that should the Inn determine in its sole discretion that my pet is objectionable to other Inn guests, I must immediately make other arrangements to house the pet outside the Inn.
11. I release Mountain Magnolia Inn from any and all liability for any injury and/or damage suffered by my pet. I agree that I assume full responsibility for any injury or damage caused or alleged to be caused by my pet and incurred or alleged to be incurred by any guest, employee or invitee of the Inn. I agree to indemnify, defend and hold harmless the Inn from and against any and all alleged or actual losses, claims, damages, liabilities, costs and expenses (including attorneys' fees and court costs) suffered by the Inn or asserted by any other inn guest, invitee employee or person arising out of or in connection with my pet's stay at the Hotel.
12. I understand and agree that the Inn retains the right to exclude my pet if in the Inn's sole discretion my pet is considered dangerous by reason of disposition or is likely to harm other guests of the Inn.
13. I confirm that my pet has all required and up to date vaccinations and inoculations and does not have any communicable illnesses or diseases.
